- 18. Discussed the American Rescue Plan proposed projects.
- 19. Commissioner Morales made the motion to approve repair quote from RGV Industrial for the transfer pump in the amount of \$5,595.00 and the quote for the Hi-service pump #3 in the amount of \$2,660.00 for the water treatment plant; payable from the covid reimbursement monies. Commissioner Chavez seconded. All approved and motion carried.
- 20. Commissioner Morales made the motion to approve to repair Sunset Lift Station Pump #1 by Valley Armateur Works in the amount of \$1,500.00 (rebuild); warranty 1 year; payable from the covid reimbursement monies. Commissioner Chavez seconded. All approved and motion carried.

- 21. Commissioner Chavez made the motion to charge \$100.00 fee to haul fill dirt to the Lyford residents requesting dirt; free to the resident if they pick up themselves. Commissioner Cavazos seconded. All approved and motion carried.
